> The purpose of the TOR program was to assist in addressing the overdose crisis in Tribal communities by increasing access to FDA-approved medications for the treatment of opioid use disorder (MOUD), and supporting the continuum of prevention, harm reduction, treatment, and recovery support services for opioid use disorder (OUD) and co-occurring substance use disorders. The TOR program also

supported the full continuum of prevention, harm reduction, treatment and recovery support services for stimulant misuse and use disorders, including for cocaine and methamphetamine. Dr. Rojas provided clinical assessment and management of TOR patients and programming and interfaced with TOR partner providers to ensure the best treatment experience for tribal members. He provided community education, network and partnership building to develop a Continuity of Care framework for CPN Health Services using agencies/providers within the Shawnee and greater OKC area. Dr. Rojas worked to reduce stigma through podcasts, articles in the tribal newspaper, and quest editor contributions.

Also served as the psychologist for this project, Dr. Rojas provided clinical assessment, management and referrals for behavioral health patients suffering from opioid/substance use disorder (OUD) (SUD).

Responsibilities include providing on-site training to all state funded treatment programs in Oklahoma, responding to the staff development training needs of ODMHSAS, and serving as a resource on the OUHSC campus and to the community.



Highlights about the Venn Diagram

 Issued in 2012 and Received Award from Office of Information Technology in 2016 for the first clinical copyright of its kind, that also earned licensing fees

- Venn diagram provided the clinical framework for ExecuCare, a program I developed to address addiction, mental illness, and trauma in healthcare professionals and executives in 2005.
- Authored several articles in journals and national addiction magazines/newsletters on the Venn diagram.
- I have presented nationally on the Venn diagram at addictions conferences and the National Federation of Physician Health Programs.
- The Venn diagram provided the clinical framework for Women's 90 residential treatment Center in Pink, OK in 2013, Milagro Ranch. I was a co-founder.
- Milagro Ranch sold to Valir Health and rebranded as Vizown. Valir Health purchased the exclusive licensing agreement for the Venn diagram from 2014-2018.
- Venn diagram used as clinical DNA to develop The Addiction Recovery Center (ARC) detox in 2015 at Valir Hospital. I was a co-founder.
